

# Hope and Health in the Hill Country – A Partnership for the Future of Nursing

Peterson Health is excited to announce a groundbreaking collaboration with Schreiner University aimed at inspiring local high school students to pursue rewarding careers in nursing. As part of this initiative, two new endowed scholarship funds—the first contributions to this vital program—have been established to support students dedicated to healthcare. These scholarships were made possible by the generosity of two local families who share a vision for investing in the future of healthcare in the Kerrville area.

The *Michael M. Baumann Memorial Endowed Scholarship* and the *Dr. William E. Morris Scholarship*, both established in 2024, are designed specifically for students planning to study nursing at Schreiner University. As part of this unique program, scholarship recipients commit to working with Peterson Health for a minimum of three years after graduation. This "pay it forward" commitment fosters a cycle of local healthcare talent, ensuring that Peterson Health—and the wider Hill Country community—benefits from skilled, compassionate professionals for years to come.

The scholarships provided by Peterson Health will support Junior and Senior nursing students at Schreiner.
